**A RESOLUTION ACCEPTING A MONETARY DONATION FROM
THE CONSTRUCTION SAFETY COUNCIL OF NORTHEAST OHIO
TO THE CITY OF STRONGSVILLE POLICE DEPARTMENT.**

WHEREAS, the City of Strongsville Police Department's K-9 unit program began in 1995. Some of the K-9's duties include narcotic detection, tracking wanted or lost people, article searches, building searches and criminal apprehension; and

WHEREAS, additionally, the K-9 officers/handlers occasionally do lectures and demonstrations for many groups such as civic organizations and school functions; and

WHEREAS, the Construction Safety Council of Northeast Ohio promotes safety in the construction industry through educational activities and provides a forum for safety and health information; and

WHEREAS, in 2024, the K-9 unit provided a demonstration of the unit's unique abilities when performing their duties to the Construction Safety Council of Northeast Ohio; and

WHEREAS, in appreciation for such demonstration, the Construction Safety Council of Northeast Ohio has graciously donated a check in the amount of \$1,000.00 to the City's Police Department; and


WHEREAS, the City is desirous of accepting such generous donation.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF STRONGSVILLE, COUNTY OF CUYAHOGA AND STATE OF OHIO:

That the Mayor and this Council hereby graciously accept a monetary donation in the amount of \$1,000.00 from the Construction Safety Council of Northeast Ohio to the City of Strongsville Police Department in appreciation for providing their organization a demonstration of the K-9 unit's duties.
